

## **Special Board Meeting Minutes**

# North River Estates Community Association, Inc

A special meeting of the elected directors of the North River Estates Community Association, Inc was held on Thursday, June 9<sup>h</sup>, 2022 at the Clubhouse, 7001 36<sup>th</sup> Street E., Ellenton, FL 34222.

The meeting was called to order by Mrs. Mellott, President at 3:00pm.

Present were Kathie Mellot, Peggy Bader, Erik Hollick, Jeff Albrecht & Pegi Chamberlain.

President Comments by Mrs. Mellot - The board is working on the Colony Cove boundary line.

Mr. Albrecht, Secretary reported that all members were properly notified by notice and the agenda posted on property June 6<sup>th</sup> and via email. A quorum is present. Mrs. Mellot made a motion that the reading of the May 12<sup>th</sup> BOD minutes be waived, 2<sup>nd</sup> by Mrs. Bader. - Capital Projects Mrs. Mellott had nothing new to report on the pool and deck refurbishing.
- Facilities & Grounds Mrs. Bader reports that an Environmental Resource Inspection is due 10/3/22. Seeking quotes for the inspection by certified engineer. Contacted G. Fisher who did prior inspection. Have a quote from Zoller Engineering.
- Social Committee Mrs. Chamberlain the social committee has disbanded and all funds in their account will be held by the BOD. Encouraged residents to create their own event and committee on an event-by-event basis. Mrs. Chamberlain will act as liaison between the board and social committees for events. At this time Veterans Day 11/11 & Christmas Party 12/16 are the 2 events scheduled.

Mr. Hollick made a motion to appoint Margaret Chamberlain as Acting Secretary, 2<sup>nd</sup> by Mrs. Mellott. All approved 4-0.

- ARC Approvals: Lot #18 to paint shed side & door, #81 removal of storm damaged palm tree, #85 reapproved ARC request from May 12<sup>th</sup> as contractor modified plans to place propane tanks in rear of house. #85 plant shrub in front of FLP meter. Motion made to approve all by Mr. Albrecht, All approved 5-0.
- Welcome letter to new residents Lot #56.
- Mr. Hollick read aloud the new Display of Flag, Political & Advertising Sign Policy. Policy was written in accordance with Florida State HOA Guidelines. Will be presented for a vote at July meeting.
- Mr. Hollick looking for volunteers for the following areas: Grants, Maintenance, Community Projects, renewable Energy sources, Social Committee & Newsletter. A sign-up sheet for the Maintenance volunteers was placed on check-in table.
- Mr. Albrecht thanked Dan Tellier and Larry Charette and others for landscaping front of clubhouse.
